

Expanded Addendum

GEHRIMED now includes an expanded Addendum feature that enables the billing provider to update the CPT and ICD data associated with a GEHRIMED Encounter after signature along with text amendments to the signed encounter document.

Updating the CPT and ICD information in GEHRIMED will impact several different areas including:

Encounter Card: The primary CPT code on the Encounter card will reflect CPTs added or removed utilizing the expanded addendum.

Quality Measures: Updating the CPT and/or ICD information on the encounter utilizing the expanded addendum will update patient/encounter's Quality measure eligibility.

Billing Information: An additional billing report will be delivered if the Expanded addendum feature is enabled.

ICD Billing History and HCC value indicator: The Billing History associated with ICDs on the patient's problem list will be updated to reflect ICDs added or removed utilizing the expanded addendum

Relative Value Units: Information on the RVU dashboard will reflect CPTs added or removed utilizing the expanded addendum.

The Expanded Addendum feature is enabled and configured by GPM Support for your practice. Contact your GPM Support representative to enable the Expanded Addendum.


Comparison to the Standard Addendum





Diagnosis and Assessment Addendum

On the Diagnosis and Assessment Addendum, update the ICD and CPT coding as you would for an unsigned encounter.

Current Document

The Current Document tab displays the signed encounter in its current state.

Clinical Addendum

The Clinical Addendum Tab is used to add text to the document under the **Clinical Addendum** header.

Facility Change Addendum

The Facility Change Addendum enables you to update the facility associated with the encounter, exactly as the changing the facility utilizing the “Change Criteria” If the CPT Restriction type of the facility is now changed, the CPT and facility must now align.
